2. Priority will be given to applicants not receiving any other grants from other organisations.
3. Application must be submitted with required documents by **10 May 2024**. Allowance will be disbursed at the end of every month starting from the month the application is approved to December 2024. Disbursement will be made through inter-bank GIRO to the student's account.
